## Who and what are we?

Started in 1997, Certified Transportation Network is an exclusive Network of Independent and Professional Freight Forwarders. By exclusivity, we allow ONE member per country excluding China, India and USA owing to the size of the countries. We are a NON Profit network and all annual dues are used to run the network and provide Credit Protection Cover for our members.

## Types of Membership available?

A regular CTN member pays for a full market/country excluding USA/India & China. The full member retains rights to their regions as long as they pay their dues in the timely manner, participate in meetings, and regularly work with members. A full member also retains an equals hare of ownership property on all to the total number off all members in the organization. Full members are entitled to vote on all issues and receive full benefits of credit protection.

Approved Service Providers(ASP's) are required to meet the full critierial for membership and may participate for up to ONE year at a reduced fee(50%ofannual fee) however retain NO rights of membership, which means they do not receive market rights, voting rights, credit protection or any other CTN provided service. They AS P are expected to attend the Annual Meeting and meet the members. After the first year, they are required to sign on as a full member or they may be asked to withdraw their association.

Companies must be able to handle various types of general cargo and must be active in their local markets.

### Credit Protection Policy

---

This plan is designed to provide Members with protection against accounts receivable losses due to the bankruptcy or default of a CTN member. The plan is intended to function as an insurance policy, and each member will be responsible for adhering to the policy requirements in order to receive payment. The plan is NOT intended to prevent losses from poor credit practices. For example, it will not protect a member if the member prepays freight for a large sum of money to a destination with restrictive financial controls, excessive fluctuations etc.
